- Processing for the purpose of providing health care services

For the purposes of patient identification, the provision of healthcare services, medical diagnosis and treatment, and the keeping of medical documentation and records, we process data whose scope depends on the type of healthcare service provided and the medical documentation required. Such data may include identification and demographic data, permanent and temporary residence data, contact details, health insurance data, the Unique Master Citizen Number, and other prescribed identifiers, as well as data concerning health, personal and family medical history, diagnoses, therapy, healthcare services provided, examination and test results, genetic data and other data necessary for the provision of healthcare, depending on the specific service.

This does not apply to emergency medical care where such care must be provided without delay.

Another MediGroup system member may access the patient’s data only where an appropriate legal basis exists and access is necessary for the relevant purpose. At the patient’s explicit request and with the patient’s explicit written consent, the data may be made available to other MediGroup system members for the purpose of providing comprehensive and efficient healthcare services.

At the patient’s explicit request and with the patient’s written consent, laboratory results and other medical documentation may be sent to the email address specified by the patient.

The data are processed electronically and, where necessary, in paper form, with appropriate safeguards in place. Medical documentation and records are retained for the periods prescribed by Article 39 of the

Transfer of personal data and biological samples for the purpose of performing laboratory analyses in Member States of the European Union

Mehiläinen is an international healthcare group of which the MediGroup system forms part. The Mehiläinen Group includes healthcare institutions and laboratories located in European Union Member States that have the expertise and technical capabilities required to perform certain specialised laboratory analyses. Therefore, where necessary for the provision of healthcare services, certain analyses may be performed in cooperation with these laboratories.

For the purpose of providing healthcare services, medical diagnostics and performing certain specialised laboratory analyses, the Healthcare Institution may refer certain laboratory analyses for

Together with the biological sample, only those personal data that are necessary for the proper identification of the patient and the sample, the performance of the requested laboratory analysis and the delivery of the result to the Healthcare Institution are provided.

Such data may include: the patient's name and surname, Unique Identification Number, date of birth, gender, sample identification number/barcode, as well as information on the type of laboratory analysis requested.

The Unique Identification Number is provided to the laboratory only where necessary for the accurate and reliable identification of the patient and biological sample and where that purpose cannot be reliably achieved by using the sample identification number or another identifier that is less intrusive to the patient's privacy. The biological sample and the above data are processed exclusively for the purpose of performing the requested laboratory analysis, preparing the laboratory report and delivering the result to the Healthcare Institution. The Healthcare Institution does not provide a broader scope of data than is necessary to achieve the stated purpose.

Laboratories receiving biological samples and data act as independent data controllers in relation to the processing they carry out within their professional laboratory activities.

MediGroup SEE, as the parent company of the MediGroup system, has entered into a framework personal data processing agreement with the Mehiläinen Group. The agreement governs the circumstances in

All participants in the processing are required to implement appropriate technical, organisational and personnel measures to protect personal data. These measures include restricting access to authorised personnel, confidentiality obligations, secure data transmission, proper labelling, transport and traceability of biological samples, protection against unauthorised access, loss, alteration or misuse, and appropriate procedures for responding to security incidents.

The transfer of personal data to Member States of the European Union is carried out in accordance with the Law on Personal Data Protection, taking into account that the data are transferred to countries considered to ensure an adequate level of personal data protection. Such transfer is carried out without the need for specific approval from the Commissioner, while respecting the principles of lawful, fair and transparent processing, purpose limitation, data minimisation, accuracy, confidentiality and integrity of data.

The results of laboratory analyses and accompanying medical documentation are retained in accordance with the retention periods prescribed by applicable regulations governing medical documentation and records in healthcare, as well as the internal acts of the Healthcare Institution.
